## WAIVER AND RELEASE OF LIABILITY

In consideration of **Elizabeth City X-treme Paintball Park, LLC** furnishing services and /or equipment to enable me to participate in paintball games, I agree as follows:

I fully understand and acknowledge that; (a) risks and dangers exist in my use of Paintball equipment and my participation in Paintball activities; (b) my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of **Elizabeth City X-treme Paintball Park, LLC**; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of **Elizabeth City X-treme Paintball Park, LLC**, or by any other person. I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify **Elizabeth City X-treme Paintball Park, LLC** and it's owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Paintball equipment or my participation in Paintball activities, I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of **Elizabeth City X-treme Paintball Park, LLC**.

1. Referees are here for your assistance, questions and safety.
2. **MASKS MUST REMAIN ON AT ALL TIMES when on the field.** Reminders will be given when walking on the field. After 1 warning, Referees will suspend 1 game. After 2 warnings you will not be allowed to play the remainder of the day. No Refunds will be given.
3. **BARRELL COVERS MUS REMAIN ON AT ALL TIMES when not on the field in active play.**
4. Be respectful to players and staff at all times. Cursing, stealing, overshooting, cheating etc. will not be tolerated.
5. **Elizabeth City X-treme Paintball Park, LLC** is a Field Paint Only Facility.
6. **Elizabeth City X-treme Paintball Park, LLC** allows players to bring food and drink. We DO NOT allow alcohol of any kind. Doing so will terminate play. No warnings. No Refunds.
7. Markers will be checked for speed and should be semi auto and under 285fps.

### Play Rules

1. Games start only when Referees gives the signal. Players are not allowed on the field without Referees.
2. Call paint check if you are hit but cannot see if the paintball broke.
3. Only fire when you can see a target. No blind firing.
4. If hit and out, Scream "hit" or "out", put on barrel cover, raise your marker and walk off the field. **KEEP YOUR MASK ON.**
5. If your marker malfunctions on the field, repeat #4.
6. Players are required to accept "surrender" if within 10 feet of an opposing player. The player surrendering should repeat #4.

**I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE ELIZABETH CITY X-TREME PAINTBALL PARK, LLC FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.**
